In the event any portion of the Membership Deposit or Membership Fee has been financed or deferred or is owing to the Club, Member shall be obligated to pay in full to Owner the remaining unpaid balance of the Membership Deposit or Membership Fee as a condition precedent to resignation. Memberships are nontransferable and nonrefundable.
